SDSB Faculty's Research Article Accepted for Publication in Gender & Society

Suleman Dawood School of Business (SDSB) faculty, **Muhammad Azfar Nisar's** research article, '(un)becoming a man: Legal consciousness of the third gender in Pakistan' has been accepted for publication in Gender & Society (ABDC A*). This is Dr. Nasir's third A/A* publication since joining SDSB and fourth overall.



Abstract:

In the last decade, a few countries have created a third gender category to legally recognise gender non-conforming individuals. However, we know relatively little about the response of the gender non-conforming individuals towards the legal third gender category. To address this gap, this article analyses the different social, religious, and institutional discourses that have emerged around the recently created third gender category in Pakistan and their influence on the legal consciousness of the Khawaja Sira community, a marginalised gender non-conforming group. Even though the third gender category was created to address the unique gender identity of the Khawaja Sira community, most continue to legally register as men. My research indicates that patriarchal stigma, high compliance costs and limited material benefits associated with the legal third gender category dissuade the Khawaja Sira community from choosing to register. My findings point to the limitations of a legal third gender category within a patriarchal socio-legal order where important benefits associated with the masculine identity are forfeited by registering. In doing so, my research cautions against over emphasising the symbolic value of legal recognition for gender non-conforming groups.

Research Seminar on CPEC and Role of Business by Dr. Salman Shah

Dr. Salman Shah has served as Finance Minister of Pakistan from 2004 to 2008, a period of extensive economic reform and changes. His tenure was significant for the development of the private sector, large FDI flows into the country and a successful return to international capital markets with the issuance of global depository receipts, Eurobonds and Islamic Sukook bonds.



He has also been a member of numerous committees at major national financial institutions such as the State Bank of Pakistan, the SECP, the National Institute of Banking and Finance among others.

As Finance Minister, he has negotiated with international finance institutions, investment banks, foreign investment houses, hedge funds, rating agencies and multinational corporate investors besides other national governments and major trading partners.

He has a Ph.D. in Finance from Indiana University and has also taught at University of Toronto, Indiana University, University of Michigan and Lahore University of Management Sciences. He currently consults for and provides strategic advice to corporations, financial institutions in the power, energy, textiles, engineering and agriculture sectors as well as advising several Central Asian countries on financial management and establishment of controls.

Pakistan Women Entrepreneurship Programme Holds Women Summit 2017

Pakistan Women Entrepreneurship Programme (PWEPP), a joint venture of Lahore University of Management Sciences (LUMS) and American University (AU), Washington DC wrapped up its activities for the second phase with a Women Summit on August 9, 2017.



The programme is supported by the US Department of State and US Pakistan Women Council. Starting in 2014 under the umbrella of Social Enterprise Development Centre (SEDC) LUMS, Pakistan Women Entrepreneurship Programme has trained 88 business women in different areas of business management including marketing, accounting, supply chain management, finance and leadership.

The Women Summit on Wednesday brought together entrepreneurs from the first and second cohort of the programme. The summit started with a welcome note by the Programme Director, Dr. Misbah Tanveer Chaudhary, followed by a guest speaker session on the importance of company registration for entrepreneurs. The session was delivered by Ms. Shazia Suleiman, President Women Chambers of Commerce and Industry, Lahore.

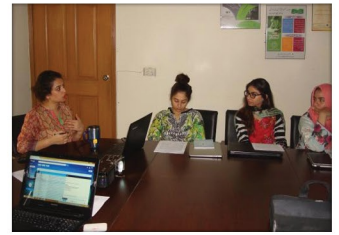
Ms. Kimberly Cayce, Adjunct Professional Lecturer, and Ms. Stephanie Fischer, Director Experiential Learning, from American University conducted a ninety-minute workshop with the participants on Business Improvement Planning. It was followed by a session on debunking myths about commercial bank loans by Mr. Hafiz Muhammad Azeem Malik, Relationship Manager (SME & Commercial Loans) Allied Bank Limited. At the end of the session, women entrepreneurs shared their experience of being a part of the PWEPP, how they implemented the training into their businesses and the results achieved.

The event was also attended by Dr. Jawad Syed, Dean Suleman Dawood School of Business, LUMS and guests from the US Consulate Lahore; Mr. Yuriy Fedkiw, Counsel General; Mr. Michael Guinan, Public Affairs Officer and Mr. Tanveer Hassan, Cultural Affairs Officer. The guests praised the programme and emphasised on the need of taking such initiatives for the promotion of women entrepreneurship.



SEDC's Summer Trainee Programme 2017

The Social Enterprise Development Centre (SEDC) at the Suleman Dawood School of Business (SDSB) launched its internship programme to enhance the capacity of students interested in the development sector.



The programme is designed for LUMS' students with an interest in policy issues related to development and fact sheets on specific issues that the Centre is working on. The internship has honed technical writing skills and provided exposure to interns to enter the development sector post-graduation. The programme had 3 modules with deliverables at the end of each:

Students were also engaged in the development of project proposals and marketing activities that the Centre has in the pipeline.

Fact Sheet writing skills development

Immersion Module: Punjab Commission on the Status of Women

Following the successful completion of the first two modules of the internship programme, in order to provide practical experience to the students, the SEDC has engaged the trainees with the Punjab Commission on the Status of Women. The students were exposed to a professional work setting and were able to gain first-hand experience in a development

sector organisation. The students were also required to write research-based reports, based on primary as well as secondary research methods, after successfully completing their term at the organisation.

Immersion: Practical Work Experience

The cases currently being worked on include Access to Criminal Justice System for Women in Punjab, Cyber Crime-Pakistan Electronic Crimes Act, Punjab Safe Cities Authority App, and Long Term Impact of Crime on Victims of Violence.

The purpose of the immersion module was to provide the trainees with exposure to primary data and research through field work, as well as to engage with secondary data to gain a thorough learning experience. The internship will culminate in a September Policy Forum, where students will be given an opportunity to present their policy briefs to policymakers, development sector professionals and academics. This will also provide students with critical networking opportunities.

Immersion Module: Punjab Commission on the Status of Women

SEDC inaugurated their six week Summer Trainee Programme this June, in collaboration with the Punjab Commission on the Status of Women (PCSW). The programme was devised as an immersion platform for students interested in pursuing careers in the development sector.



Since 2001, SEDC has worked on gender mainstreaming and social inclusion in Pakistan. To this end, the Traineeship was aimed at enhancing the capacity of students to better address the needs of the development sector; particularly focusing on developing technical research and writing skills. The students were taught to prepare factsheets and policy briefs on various areas of research.

The factsheets were used to shed light on Healthcare Service Delivery in Pakistan, Primary Schooling in Pakistan, Enrolment, Dropout Rates and Out-of-School Children in Public Primary Schools, Youth Unemployment in Pakistan and Financial Inclusion in Pakistan. Factsheets also focused on women's issues including Women and Agriculture in Pakistan, Maternal Healthcare in Punjab and Domestic Violence against Women in Pakistan.

The policy briefs focused on topics such as Urbanisation in Pakistan: The Availability of Housing, Poverty Alleviation through the Benazir Income Support Programme, Child Malnutrition in Punjab, Women and Agriculture in Pakistan, Domestic Violence against Women in Pakistan and Primary Healthcare Service Delivery System in Punjab.

The PCSW was engaged to add a practical dimension to the programme. Securing women's rights and empowerment are central to the work of the PCSW and mirror the cross-cutting theme of SEDC. Therefore this formed the underlying basis for the research studies conducted by the trainees. The trainees were sent to work in the field on PCSW projects as well as at their headquarters. The exposure gained through involvement in professional work settings served to familiarise them with the demands of the sector.

Among the topics assigned was the Access to Criminal Justice System for Women in Punjab. The purpose of this research was to ascertain reasons for the undue delay in conviction in criminal cases of violence, especially rape and "honour" killings committed against women. It analysed the causes of non-prosecution in such cases, and provided a set of recommendations to be shared with all stakeholders to improve the accessibility of the criminal justice system for victims.

The Audit of Punjab Safe Cities Authority (PSCA)'s Women Safety Smart Phone Application was also unpacked to assess its utility and recommendations to further improve the initiative for better safety measures for women in Punjab.

Additionally, the long-term impact of crime on women victims of violence was assessed to determine the physical, socio-economic and psychological impact on women. For primary research, PCSW's Transitional Home for Women Victims of Violence, Darul Aman, and Human Rights Centre for Women in Lahore were engaged. This research was aimed at the development of victim advocacy toolkits including procedural norms for all stakeholders involved to protect the rights of victims.

The Prevention of Electronic Crimes Act 2016 (PECA) was evaluated to assess the impact of this legislation following its promulgation last year. The desk review conducted in this area of research to analyse the Act was based on academic literature and expert reviews. Data on crimes reported to the Federal Investigation Agency (FIA) and other official sources was collected to gauge its effectiveness.

The traineeship will culminate in a September Policy Forum, where students will be given an opportunity to present their policy briefs to policymakers, development sector professionals and academics. This will also provide them with critical networking opportunities. SEDC's trainee programme will serve as a launching pad for students hoping to work in the nonprofit sector, industry and the policy world.

Under its custom portfolio, REDC strengthened education sector's capacity on one hand through "Case Method of Teaching" for Air University and on the other hand launched a series of its corporate leadership programmes for Unilever sales team. Structured to spark self-reflection, innovation, and collaboration, the programmes aimed to create a learning laboratory for generating breakthrough ideas. Additionally, in continuation of building public sector expertise, REDC also conducted a 2nd cohort of 'Management of Public Sector Sourcing and Procurement' programme for Public Procurement Regulatory Authority (PPRA). All the programmes were well received by the participants with key appreciation for interactive learning pedagogy, teaching expertise, in-depth knowledge of the faculty team, high quality of programme management and centre's ambiance and support.

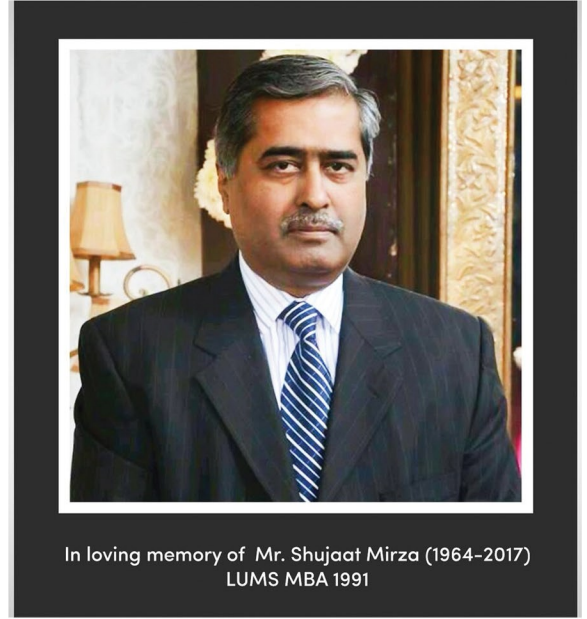
In Fond Memory

With a heavy heart, we bid farewell to one of our bright students at SDSB. Ayesha Zahid, a student of SDSB, UG 2019 passed away on 18 September 2017. We grieve for her loss as she was a vibrant young soul who was full of promise. May God accept Ayesha in his mercy and give her family and friends the support to bear this enormous loss.



It is with deep sorrow that we announce the demise of LUMS alumnus, Shujaat Mirza, MBA Class of 1991, on September 27, 2017, aged 53. He passed away at the Hong Kong airport, where he had gone for a business meeting. Mr. Mirza was the CEO of Advance Fashion Limited & Stylers International, ex-CEO of US Denim Mills, and a cherished member of the LUMS alumni community. Mr. Mirza is survived by his wife and three children, two daughters and a son. We offer our deepest condolences to his family. May God rest his soul in peace and give strength to his family to bear this immense loss. Former colleague, Kashif Bashir, LUMS MBA 2008 while remembering the deceased said: "Mr. Mirza had a close working relationship with LUMS and had been a contributor to various initiatives including the Ikanway Auditorium at LUMS, sponsoring an MBA student every year with the his class and supporting the LUMS National Outreach Programme. He set up Nishat Dyeing and

Finishing and later US Denim Mills and Advance Fashion Limited. A great leader and a kind human being, he has left his teams and previous colleagues in tears. I worked very closely with him for five years, July 2008 – January 2013. I never saw him angry or yelling at anyone, despite pretty harsh business and economic conditions and some very lousy mistake on my part or my colleagues. There is no example of him firing anyone, due to reasons other than dishonesty, cheating or outright rebellion. A very kind person at heart, he was a mentor to a lot of leaders in today's textile industry. Anyone could go to him openly and discuss his problems and somehow he always had the time to listen to us despite the fact that he was the CEO and a great one too. Those who have worked with him directly are in tears due to his untimely demise, as he was just 53 years old. Such was his behaviour with his professional subordinates that I cannot imagine the relationship he had with his family which includes a grieving widow, two daughters and a son. Just thinking about their grief is enough to sadden anyone. We cannot imagine what they must be going through. Please spare a couple of minutes to offer fatiha for the deceased soul and join us in praying to the Creator for his endless and countless blessings on Mr. Mirza's soul and a humble request for his maghfirah and highest rank in Jannat ul Firdous."
